Information regarding RoHS, REACH, PFOS, PFOA and PAK

Dear Sir or Madam,

We regularly receive requests from some of our customers to confirm the conformity of our deliveries with the applicable regulations regarding dangerous chemical substances and to fill in the corresponding documents. However, such "declarations of conformity" are not provided by the legislature and, moreover, do not meet the prescribed information requirements of the trade. Therefore, please understand that we neither make general statements nor make any statements regarding individual substances. With regard to the "obligation to disclose information about substances in articles" (Article 33 of the REACH Regulation), we would like to inform you of the following:

The so-called candidate list according to Article 59 of the REACH regulation is published by the European Chemicals Agency (ECHA) and continuously updated (see <http://echa.europa.eu>). We currently do not have any information from our suppliers that substances from the candidate list (so-called SVHC substances, Substances of Very High Concern) are contained in the products or packaging that we deliver to you, above the legal limit values nor related to PFOA / APFO. If we receive appropriate information in the future, we will forward it to you without being asked.

We will of course meet the requirements placed on retailers by the REACH regulation, in particular our information requirements from Article 33. We will inform you about relevant material changes in our delivery products as part of our business relationship and in individual cases we will coordinate suitable measures with you.

We thank you for your trust and wish you continued cooperation.
